

**PEANUT'S PLACE**  
**Owner Release Contract**

*LIABILITY*

- I (the owner) understand that if my dog(s) has a history of aggression, Peanut's Place, Inc. reserves the right to refuse service.
- I understand that I am liable for any medical expenses and damages that result from injuries caused by my dog(s).
- I expressly waive and relinquish any and all claims against Peanut's Place, Inc., its employees and representatives, except those arising from negligence on the part of Peanut's Place, Inc.
- I have disclosed to Peanut's Place, Inc. all known dangers associated with my dog(s).
- I expressly understand and agree that Peanut's Place, Inc. shall not be held responsible for any damage to my property, or that of others, caused by my dog(s) during the period in which they are in its care.
- I understand that under no circumstances will Peanut's Place, Inc. be liable for consequential damages or damages beyond the replacement value (up to \$500.00) of my dog(s).
- If any medical problems develop while my dog is in the care of Peanut's Place, Inc. I authorize Peanut's Place, Inc. to do whatever they deem necessary for the safety, health and well being of my dog(s). Further, I agree to assume full financial responsibility for any and all expenses incurred.
- I understand that Peanut's Place, Inc. is a cage-free facility. I accept the risks involved and agree that Peanut's Place, Inc. is not liable for any injuries or illnesses during my dog's attendance.

*PAYMENT*

- I understand that payment for services rendered must be made no later than the time of pick up.
- I understand that daycare packages will be paid for at time of purchase and are valid for 30 days.
- I understand that daycare reservations must be cancelled 24 hours in advance or I will be charged the same.
- **DAYCARE CUSTOMERS:** I understand that the hours of operation are 7:00am-6:30pm Monday through Friday and 8:00am-6:00pm Saturday-Sunday and that a \$10 late fee charge (per dog) applies at 6:31pm and again at 6:46pm M-F and 6:01pm and again at 6:16pm Sa-Su. If I have not picked up my dog(s) by 7:00pm M-F and 6:31pm Sa-Su, my dog will be boarded overnight at Peanut's Place and I will be responsible for late fees as well as boarding fees.
- **BOARDING CUSTOMERS:** I understand that I must check-in by 3pm on the first night's stay. I understand that if I check out by 10am, there will be no charge for that day.
- I authorize Peanut's Place, Inc. to charge my credit card for any outstanding balance on my account.
- I understand that if a balance remains for 60 days or more, unless another arrangement is made, my Peanut's Place, Inc. account will be turned over to a collection agency and that as a result I will be liable for collection costs and legal fees, in addition to the unpaid balance.
- I understand that Peanut's Place, Inc. has the right to refuse service at any time and for any reason.
